# Function Hire Terms and Conditions

## Definitions

Venue: Refers to the Flinders Tavern by Burger Theory, a registered business Burger Theory Pty Ltd, of 8-10 Union St Adelaide, SA, 5000, ABN: 25 159 799 658

Hirer: Refers to the person booking the function

## Bookings

Bookings are not confirmed until the Security Deposit is received by the venue. If there is more than one party interested in a particular date, venue management will allow the first interested party a 24-hour period to confirm the booking with a security deposit.

### In-Venue Function

Bookings for in-venue functions are permitted between the hours of 8am and 8pm, Monday to Friday, for a maximum of 2 hours. Bookings outside of operating hours are deemed 'Venue Takeover' functions and are subject to separate terms and conditions.

### Interior Plaza View Space (Standing Capacity: 80)

On confirmation of a booking, a cordoned off area on the interior of the eastern side of the Tavern (Interior Plaza View Space) is exclusive to the hirer for the duration of the function. In-Venue function bookings require a minimum of 40 guests.

### Security Deposits:

Interior Plaza View Function Space:

- \$200 Deposit a minimum 14 days prior to the function
- Minimum bar spend of \$500 including food on the night
- Please place food orders 14 days prior to the function to ensure a smooth service

Payment accepted: Cash, EFT, EFTPOS or credit card. Please note: any payment fees will be charged to the hirer. Failure to pay the deposit in a timely manner forfeits the booking. Security deposits will be credited to the hirer's account on the day of the function, provided the minimum spend is met, and after inspection of premise and property by management.

**Payments:** The final payment for the function is to be made in full at the conclusion of the function unless credit arrangements have been established prior. We accept Mastercard or Visa credit and debit cards.

### Confirmation of Guests and Menu Selections:

Guest numbers, including any dietary requirements and allergies, are to be confirmed no later than 14 days prior to the event to ensure correct food preparation and staffing requirements are met. Any other food requirements are to be supplied by the venue. More food can be ordered on the night subject to availability.

### Cancellation:

In the event of a booking cancellation less than 14 days prior to the function date, the hirer forfeits the Security Deposit Bond.

### Prices:

All beverages are charged at bar prices unless a special offer has been prearranged with venue management. All prices are inclusive of GST.

## Right of Refusal

If at any time during the function a patron in the space cannot be identified as a function guest, the patron will be instructed to leave the area. The venue adheres to all South Australian licensee laws and obligations. Management reserves the right to refuse service to, or remove from the function premises, any guest who displays unruly or intoxicated behaviour. Management retains the right to refuse service of alcohol to any person who cannot provide a relevant proof of age document.

## Damage

Repairs for damages to premises and property caused by function guests will be the liability of the hirer. The cost for such will be professionally assessed and deducted from the security deposit. In the event that damages exceed the security deposit the hirer is liable and will be charged accordingly.

## Audio Visual and DJ

The Interior Plaza View function space has a flatscreen TV and Projector available for the hirer's use. The hirer is to supply the device for play, for example, a laptop, USB or DVD player. These components should be tested by the hirer prior to the function. There is a microphone and podium stand available for hirer's use. Please arrange booking with management prior to the function.

Please be aware that the Flinders Tavern is bound by restrictions on noise levels, therefore must be informed upon confirmation of booking of any equipment, music or other entertainment you may wish to use. In-house music is played throughout the venue. This music can be streamed into the Interior Plaza View space upon request for functions. Alternatively, if you would like to have your own music played, this can also be arranged either through the in-house system or DJ. We do have a PA system that you may connect an iPod or mp3 player to but this must be prearranged with management.

**Decorations**

Time to decorate or leave articles for your function space is to be arranged prior to the function with management. Strictly no confetti style decoration. Nothing is to be fixed to walls or other Tavern facilities; please use standalone materials.

**Responsibility / Disclaimer**

The Venue will be under no liability for any loss, damage or injury to the hirer's property or the property of the hirer's guests. Any breakages or property damage will be at the cost of the client.
